The <u>PFEW Demand, Capacity & Welfare Survey</u>, launched on 5 October 2020, is an opportunity for you to share your views on policing the **COVID-19** pandemic and issues that impact you in your day-to-day job.

All federated ranks will receive a link to this survey via email. This is designed to provide a clearer picture of the main challenges currently facing policing and includes bespoke questions around your experiences of working during the pandemic and the plan to recruit an additional 20,000 officers by 2023.
