Group Insurance Renewal with effect from 1 April 2020

We are pleased to confirm that our Group Insurance Scheme has been renewed for further year with our current brokers Gallaghers. We have made some slight changes to the new policy in that the maximum age for serving members of the Scheme will increase from 64 years to 69 years inclusive, and the Motor Breakdown element of the Scheme will transfer to the RAC. We have also included a retirement option for Police Staff.

Serving officers who are members of our <u>Group Insurance Scheme</u> currently enjoy life cover of **£120,000**, which your nominated beneficiary will receive in the event of your death. (Top Up' Life Insurance for Group Insurance Scheme Members)

Did you know that, if you are a member of our <u>Group Insurance Scheme</u>, you can '**top up**' your own life cover and that of your Spouse/Partner (if subscribing)?

The life cover element within our <u>Group Insurance Scheme</u> is currently **£120,000**, and Spouse/Partner life cover (available as an optional extra) is **£60,000**. There are 3 easy options to increase this cover, as follows:

- £7.15 per month providing an additional £50,000 cover
- £9.65 per month providing an additional £75,000 cover
- £12.21 per month providing an additional £100,000 cover
